



# General Business Terms and Conditions Water Polo Sports Tour & International Academy (WPSTIA)

## 1. General

Water Polo Sport & Tour International Academy (hereinafter WPSTIA) is a project of quality with outstanding performance. The Academy trains enthusiastic young water polo players at sporting, human as well as spiritual and intellectual levels. WPSTIA aims at, above all, athletic education and support for young people with enthusiasm for water polo. We follow a path that focuses on the improvement and strengthening of individual skills.

WPSTIA offers a wide range of camps, led by prestigious, internationally recognized, coaches who have designed them. These are programs based on athletic performances, both for young players who want to improve their technique and for teams who want to improve their performance to achieve success. These programs are specially adapted to the preferences of the participants, and are implemented throughout the year in Serbian (Belgrade, Bečej, Vrnjačka Banja, etc.) alike. The best sports center's for high-performance sports are available. These programs are suitable for short and long stays for players from around the world. The offers can be combined with language camps. The prestige of the Serbian water polo players consolidated over the past 35 years, is the best guarantee for this project. Various achievements of male and female teams are the best examples of the values that we would like to convey with our methodology.

Water Polo Sport & Tour International Academy is a non-profit organization (NPO) or charity organization with no economic profit whatsoever. It serves charitable social, cultural, sport, educational and scientific goals of its members. This is defined in its Statute. The realization of all our activities and projects are financed through sponsorship and donations. We reduce costs with the help of volunteers. Thanks to our sponsors and partners, WPSTIA can offer an unbeatable price-performance ratio. We are very grateful for the valuable youth work. All our coaches, tutors, teachers and assistants as well as our entire management work as Honorary Associates. Honorary Associates are not entitled to legal protection against dismissal. An honorary work is not employment relationship. The seat is in Belgrade - Serbia and representation in Basel-Stadt (BS). Water Polo Sport & Tour International Academy is an association pursuant to Art. 60 ff of the Swiss Civil Code, with the seat in Basel (BS).

Within the WPSTIA camps water polo enthusiasts (children and teens, hereinafter "participants") are professionally supervised and trained by tutors and coaches during one, two or three weeks. In the foreground there is game, fun and joy in the movement and the water polo. The WPSTIA clearly distances itself from the competition pressure within its camps.



## 2. Registration

Children and adolescents aged 6 to 40 years are eligible to participate. Registration for the WPSTIA camps must be made at least two weeks before the start of WPSTIA camps by parents or guardians.

If WPSTIA accepts the registration, the participant receives a written confirmation with an invoice for the payment of the participation fee. WPSTIA reserves the right to reject the application without giving reasons.

The definitive inclusion in the list of participants is carried out only with payment of the fees until the specified date (according to **Para. 4**). If the maximum number of participants has already been reached, other interested participants can be placed on a waiting list – without any guarantees – and, in case of cancellation, they can enter the participation list at short notice.

## 3. Information on the state of health

The registration will confirm that the participant is healthy and athletic, in full strength and can attend the training programs without restrictions. The participant takes part in the training under their own responsibility. If there are any diseases, allergies, necessary medications and other necessary information, it shall be noted during the registration.

## 4. Participation fees and payment

Participation in the WPSTIA Camp is subject to charge. The information on fees can be found on the website [www.wpstia.com](http://www.wpstia.com) and on the WPSTIA camps flyers. The fees are to be paid in advance.

The invoice amount is payable immediately after the invoice date. If paying by invoice, one-time processing fee of **20.00.- €** applies. If the application is made within a period shorter than **30 days** before the start of the camp, then the amount is due immediately. If the costs are not paid within the set deadline, the right to participate is lost. In this case, the payment obligation shall be regulated in accordance with **Para. 6**. If the participation fee is not paid within the stipulated timeframe, the right to participate is denied. In that case, payment shall be governed by **Para. 6**.

- 2% discount if paid 90 days before the start of the camp
- 3% discount for participants who have already participated four times on the camp (cannot be combined with other discounts)
- 5% additional discount on all camp bookings of 3 or more weeks
- Payment in instalments possible if you book a camp for at least 10 days before the camp registration deadline. With instalment payments, there is no discount possibility.

## 5. Water Polo Sport Tour & International Academy Camp Code of Conduct

- The participant are obliged to follow the instructions of the coach's follow and adhere to the Code of Conduct. If the instructions or the Code of Conduct are repeatedly failed to be complied, the camp management reserves the right to remove the participant from the training and/or the Camp. In this case, the participant has no rights to a refund of the registration fee.



## 6. Cancellation of participation by the participants

With a cancellation by the participant, in addition to a processing fee of **75.00.- €** the following charges will also apply:

- 90 - 60 days before the camp starts 70% of the registration fee
- 59 - 45 days before the camp starts 80% of the registration fee
- 44 - 0 days before the camp starts 100% of the registration fee

In case of cancellation due to accident or disease **45 days** before the camp starts the WPSTIA refunds the amount (reduced by **50% + 45.00.- €** of the processing fee) upon receipt of a medical certificate.

In case of cancellation due to accident or illness **44 - 0 days** before the camp starts upon the receipt of a medical certificate, please contact your travel insurance since the WPSTIA has no possibility to reimburse for the third party (hotel/airline/transport operator). We always recommend travel insurance for the athletes/tutors, **Para. 8**.

Specific and already printed equipment must be charged in any case. Until the beginning of the camp a replacement participant may be named at any time, provided they comply with the participation prerequisites (age, health, fee payment, etc.).

## 7. Cancellation by Water Polo Sport Tour & International Academy

WPSTIA reserves the right, in case of not reaching the minimum number of participants, to cancel the WPSTIA Camp (depending on the kind of camp /tournament) or for some other reasons, with the refund of the registration fee. If the WPSTIA Camp cannot be held on some days due to bad weather, these days are not refundable and the participants are not entitled to the refund of the participation fees or other compensations.

## 8. Liability in case of accident / illness / damage

The risk insurance such as accidents, illness and property damage is the responsibility of the participant. WPSTIA disclaims any liability for accidents, illness or property damage. The negligent damage and intentional damage inflicted by WPSTIA are exempt.

## 9. Liability in case of theft / loss of valuables of participants

WPSTIA is not liable for theft or loss of valuables or money. The intentional damage or negligent damage inflicted by WPSTIA are exempt.

## 10. Photo, data and film rights

Participant and their legal guardians on registering issue consent for the participants to be photographed and recorded. These photographs and recordings may be spread through the WPSTIA and any co-organizers of WPSTIA camps and publicly released (including the Internet). This applies also to their own or other promotional purposes. The participants or their legal guardians allow WPSTIA to collect, store and process personal data in connection with the registration, organization and management of WPSTIA camps.



## **11. Applicable Law and Jurisdiction**

The contractual relationship between the participant, the legal guardian and WPSTIA is exclusively governed by the laws of Serbia. The court which shall have exclusive jurisdiction to settle any claim or dispute which might arise out of or in connection with these terms and conditions is based in Belgrade.
